Please read the following agreement before you pay your bill at the Bursar's Office. Since we are an educational institution, there are certain modes of behavior that are expected of the people using our facilities. We are also a state institution and, as such, must uphold State law.

I am a **registered summer class student**, applying for summer housing under the following option: (Circle One Option)

In consideration of my assignment to NHTI, I agree to abide by the following rules:

1. Full payment for the period above is to be made prior to assignment to the residence hall. Please make checks payable to NHTI.
2. Your room is already equipped with desk, desk chair, bed, mattress, closet facilities, and a refrigerator/microwave unit. You should bring your own pillow, blankets, sheets, mattress pad, towels, study lamp, cleaning materials, and any other furnishings you want.
3. Electrical cooking appliances are not permitted.
4. Air conditioners are not permitted. A portable fan is highly recommended.
5. Room occupants are financially responsible for damage to their rooms. Any damage to public space will be billed to the responsible individual. If the responsible person cannot be found, the group will be assessed a fee for damage which will be divided between all residents. The minimum charge per person will be \$2.00.
6. A charge of \$5.00 will be made for each room key that is lost and \$25.00 for each ID lost.
7. Any violation of the rules or policies may result in termination of this contract and forfeit of monies paid.
9. Residence is offered only during academic summer sessions to registered summer class students:
 Summer Session I : May **29** – July **2, 2011**
 Summer Session II: July **3** – August **6, 2011**

Summer Session Residence Hall Refund Schedule:

1. Request for early termination of this agreement before the start of the Summer session can be considered only if received in writing by the Residence Life Department before the Friday of the start of the summer session.
2. If by Friday of the first week of classes the student fails to occupy the assigned room or cancels the agreement by mutual consent for any of the reasons in the terms of agreement, the agreement is cancelled and the student receives an 80% refund of the Summer sessions housing fee.
3. Cancellation for any of the reasons in Terms of Agreement or mutual consent after the Friday of the first week will result in no refund of the housing fees.

I understand this agreement and further agree to abide by the terms and conditions of this contract, the Residence Hall Policies, and any policy or rule as may be published or posted.
