



**NHTI, Concord's Community College
USNH Dual Admission Program
Advising Agreement**

The following items pertain to the Dual Admission Program with each of the University System of New Hampshire institutions (University of New Hampshire-Durham, University of New Hampshire-Manchester, Plymouth State University, Keene State College, and Granite State College, referred to collectively as "USNH" hereafter) except where noted.

As a NHTI student who is requesting enrollment in the CCSNH-USNH Dual Admission Program I agree to the following:

- 1. I have met with a member of the NHTI Advising Staff and understand the details of this program:**
 - a. I understand that completing my Associate degree at NHTI is a requirement to transfer to the USNH institution through the Dual Admission Program.
 - b. I understand that I must obtain a grade point average of 2.5 or higher; Granite State College will accept a 2.0 or higher.
 - c. I understand that in order for any course to be considered for transfer credit by USNH I must earn a C or better.
 - d. I understand that not all courses will transfer to the USNH institution.
 - e. I understand that if I complete all of the requirements of the program I will be admitted to the USNH institution, however, I am not guaranteed admission to any specific program or restricted major.
 - f. I must provide an official college transcript to the USNH institution from any college I have attended, regardless of whether or not I am seeking transfer credit. List Prior colleges attended: _____
 - g. To participate in this program with Plymouth State University, I must have earned fewer than 24 transferrable previous college credits.

- 2. I agree to the following as it pertains to my Academic Advising at NHTI:**
 - a. I will consult with my Advisor each semester and will register only for those courses for which I have received approval.
 - b. I will be responsible for awareness of NHTI returning student registration dates to register when there is the greatest availability of courses.
 - c. I will be aware of the academic calendar, registration policies and deadlines, and the add/drop period.
 - d. I will update advisors on accelerated credit, pending and final, including CLEP, or transfer credit scenarios to prevent duplication of courses. *(NHTI is not responsible for credit duplication.)*
 - e. I understand that I will be advised to take NHTI courses that satisfy or prepare for the USNH institution general education requirements and specific degree requirements where appropriate.
 - f. I will consult with my advisor prior to making any changes to my schedule (add/drop) and changing majors.

- 3. I understand the following as it relates to transferring to the USNH institution:**
 - a. Admission to a specific USNH program is dependent upon meeting the program's individual requirements and space availability at the time of transfer.
 - b. Transfer partnership programs (articulation agreements) have been established with the USNH institutions to guarantee transfer into certain specific programs; it is my responsibility to review these options with my advisor.
 - c. If enrolling at Granite State College, it is my responsibility to meet with a GSC Advisor to maximize transfer of courses.
 - d. If previously matriculated into a USNH institution, I am ineligible to participate in this program to re-enroll at that same institution, and must instead follow that institution's procedures for Readmission.
 - e. I must meet the USNH institution's expectation for good conduct and citizenship.
